

DEAR GUIDANCE COUNSELOR:

Your graduating high school students will once again have the opportunity to receive scholarship funds from PSECU. To qualify for one of six scholarships awarded for up to \$8,000, the student must be a PSECU member by **Saturday, December 31, 2016**.

Students interested in joining PSECU must be eligible for membership. Joint owners are not automatically PSECU members. As you can see by the enclosed list, there are many ways for students or parents to qualify for membership. The list includes state agencies, businesses, organizations and schools that all provide membership eligibility. A complete list is available at psecu.com/eligibility. Students who qualify may call or apply at psecu.com.

IMPORTANT!

Students who are PSECU members can download an application at psecu.com/scholarships. They can also call us at 800.237.7328. The application has a section the student fills out and an Academic Profile that you fill out. Students must complete their section before giving you the packet.

After the packet is completed, you must mail the packet to us. **All applications must be received by noon on February 28, 2017. NO EXCEPTIONS!** Please use the prepaid envelope (if applicable) that is sent with the scholarship application or mail to: PSECU SCHOLARSHIP COMMITTEE, P.O. Box 67013, Harrisburg, PA 17106-7013.
